Remuneration includes but is not limited to salaries and wages, taxable benefits, bonuses, stipends, MOCAP and sessional fees.

The Provincial Health Services Authority has approximately 11,000 employees for the fiscal year ended March 31, 2009. Of those, 1544 earned in excess of \$75,000.

Out of these 1544 individuals:

- 436 (28.2%) are nurses (mainly members of the British Columbia Nurses' Union and the Union of Psychiatric Nurses)
- 430 (27.8%) are administrative and management staff excluded from union membership
- 377 (24.4%) are physicians, scientists and researchers
- 276 (18%) are paramedicals (mainly members of the Health Sciences Association of British Columbia)
- 25 (1.6%) are members of other bargaining units
