Remuneration includes but is not limited to salaries and wages, taxable benefits, bonuses, stipends, MOCAP and sessional fees.

The Provincial Health Services Authority has approximately 10,000 employees for the fiscal year ended March 31, 2008. Of those, 1271 earned in excess of \$75,000.

Out of these 1271 individuals:

- 350 (28%) are nurses (mainly members of the British Columbia Nurses' Union and the Union of Psychiatric Nurses)
- 343 (27%) are administrative and management staff excluded from union membership
- 351 (28%) are physicians, scientists and researchers
- 213 (17%) are paramedics (mainly members of the Health Sciences Association of British Columbia)
- 15 (1.2%) are members of other bargaining units
