Westech Systems FM Inc. is pleased to submit the following report of the third party independent housekeeping audit process and results to B.C. Health Authorities.

Westech Systems FM Inc. is a British Columbia owned and operated company that has focused primarily on providing cleaning\housekeeping auditing services and housekeeping management software solutions for hospitals and other facilities in North America for nearly two decades. For this B.C. initiative, we carried out extensive research and built upon auditing best practices used in the U.K, Australia, the U.S., and Canada.

Between March 1st and May 31st 2005, Westech conducted an independent third party audit of all health care facilities in British Columbia. We audited 10% of all the rooms of every health care facility in each health authority in four risk categories. Of these, a higher-proportion were high risk rooms. All audits were conducted unannounced.

The overall score for a room is based on up to 19 inspection elements that have different weights associated with them, depending on the risk category. The overall percentage score for a facility is based on the average score for all rooms audited in that facility. The overall percentage score for a health authority is based on the average of all the facilities audited within that health authority.

Using an established industry benchmark of 85%, all but one of the health authorities is in excess of this target. The remaining authority scored at a level less than one percentage point below the 85% target. Based on this finding, Westech believes the hospitals and residential care facilities audited during this period displayed a level of cleanliness that was within acceptable standards. However, it should be emphasized that the recently completed independent audit should be seen only as a starting point and a measure of the cleanliness at a point in time. To accurately gauge the cleaning levels of B.C. health care facilities, we will need at least one year of independent and internal audit data to determine if any trends or patterns exist.

Westech performed the recently completed audits with a focus on consistency, and objectivity and will stand behind the results in this report and future audits that we perform. We are also committed to staying abreast of best practices around the world by undertaking research on an ongoing basis. In short, our goal is to continually improve the process to assist Health Authorities in improving the cleanliness of hospitals across B.C.

Provincial Housekeeping Audit Summary Report

Background

In late 2004, a common system for measuring health care facility cleanliness was sought on a Provincial scale – the first initiative of its kind in Canada – by B.C.'s six Health Authorities:

- Fraser Health
- Interior Health
- Northern Health
- Provincial Health Services Authority
- · Vancouver Coastal Health, and
- Vancouver Island Health Authority

Acting as a collective, the health authorities issued a Request for a Proposal (RFP 2004-VIN-004) through B.C. Bid. The RFP required the successful vendor to provide the following primary deliverables:

- 1. Develop a common set of cleaning standards.
- 2. Develop an audit system specific to the needs of the participating Health Authorities that was based upon current industry best practices.
- 3. Perform an independent third party audit to measure the cleanliness of all health care facilities in B.C. using the audit system.
- 4. Implement the new audit system for internal use at all health care facilities.
- 5. Provide standardized reporting processes for both the internal and independent third party quality audits

Westech began research for this project in December 2004. We reviewed hundreds of pages of documents, discussed relevant issues with many people and built upon our 15+ years of experience to create a strong audit plan. In early 2005, Westech Systems FM Inc. was awarded the contract by the participating Health Authorities of British Columbia. Based on best practices in the U.K., Australia, the U.S. and Canada, Westech's audit plan has since developed into a successful guide for creating a standard system for measuring health care facility cleanliness around the world.

Westech is pleased to announce that we have:

- 1. Developed a common set of cleaning standards.
- 2. Developed an audit system specific to the needs of the participating Health Authorities.
- 3. Performed independent third party audits of every health care facility in British Columbia.
- 4. Provided standardized reporting processes for both the internal and independent third party quality audits; and
- 5. Created an audit system that is currently being implemented for internal use at all the health care facilities. All of this was realized using current best practices based on extensive worldwide research and state-of-the-art computer technology.

Westech Systems FM Inc. is a British Columbia owned and operated company that has focused primarily on providing cleaning\housekeeping auditing services and housekeeping management software solutions for large hospitals and other facilities in North America for nearly two decades. Working with our sister company, QHT Technologies from Michigan, we have assisted in the development of the state-of-the-art Palm-based quality audit software used for this significant project. The current version of this software system is based on both the recent research that we have completed, and our years of experience in the development of quality audit systems for our clients.

As a firm that provides impartial, unannounced third party housekeeping audits, we are acutely aware of our independent position. As such, it is not our policy to contract housekeepers, or sell cleaning chemicals. Moreover, Westech has never been affiliated with any contract cleaning companies and/or janitorial cleaning product companies.

Prior to this provincial initiative, the majority of Health Authorities in B.C. were utilizing a variety of good - but different - systems for auditing cleanliness. With the new Provincial Housekeeping Audit System, the participating Health Authorities are now using a common system and are well on their way to working together to achieve continuous quality improvement. It should also be emphasized that B.C. has now set a new benchmark for Canada and the world in the area of health care facility housekeeping audits.

Provincial Housekeeping Audit System Overview

Some of the key components of the new Provincial Housekeeping Audit System are:

- The newly created B.C. health care facility cleaning outcome standards detailing the acceptable cleaning outcomes of the different inspection elements (toilets, walls, floors, beds, patient equipment, showers, tubs, doors, etc.) within rooms that are cleaned.
- A methodology on how to divide every area in a health care facility into four different risk categories - Risk 1: Very High Risk; Risk 2: High Risk; Risk 3: Moderate Risk; and Risk 4: Low Risk. Rooms categorized in a Very High Risk area such as an operating room have a lower tolerance for unclean inspection elements than rooms deemed Low Risk, such as a maintenance area.
- A weighted scoring system that puts more emphasis on inspection elements such as beds, toilets and other items that have a higher chance of human contact, thus increasing the risk of spreading infection. This concept of weighting is new to many of the B.C. Health Authorities and is based on global best practice methods.
- State-of-the-art software and Palm technology to make the auditing process as consistent and objective as possible by automating many of the functions that had to be performed manually with the old paper system. Major benefits include:
 - ✓ Less data input resulting in fewer human errors and significantly less time consumed.
 - ✓ Consistency amongst auditors as a direct result of standardized formulas built into the system.
- **Rigorous training programs and systems** to monitor the consistency of both the Westech independent third party auditors and the health care facility internal auditors.
- All independent third party audits and the internal audits performed by the health care facility staff will be reported on a common website for each Health Authority.

Current Progress & Future Strategy

Westech is currently in the process of implementing the Provincial Housekeeping Audit System in all six B.C. Health Authorities so that health care facility staff can perform audits internally on a regular basis. For future internal and independent third party audits, Westech is working with the different Health Authorities to set up room specific databases that will enable trending over time and help pinpoint problem areas. This is crucial since understanding the trends and problem areas will enable Westech to assist the Health Authorities in developing better ways to increase the cleanliness of their facilities. It should be noted that this first independent third party audit faced severe time constraints that made it unfeasible to create room specific databases.

Once the internal system is in place, the goal will be for the health care facilities to provide internal audits on a regular basis. Westech's independent third party audit will continue with a minimum annual frequency, and more often as required. The independent, unannounced third party audits are important in that they act as a check and balance to the internal process. The internal process is important from an operational standpoint to manage the day-to-day issues. The end result of these ongoing quality checks will be continuous quality improvement over time.

In summary, Westech is extremely proud to be part of this Provincial initiative. We are looking forward to continuing to play a significant role in the process of objectively improving the cleanliness of all health care facilities in B.C. It should be emphasized that the recently completed independent audit should be seen only as a starting point. To accurately gauge the cleaning levels of the B.C. health care facilities, we will need at least one year of independent and internal audit data to determine if any trends or patterns exist.

It should also be emphasized that by no means has Westech concluded with our research of cutting edge auditing procedures. Westech is committed to staying abreast of best practices around the world by undertaking research on an ongoing basis.

Third Party Independent Audit Summary Results:

Between March 1st and May 31st 2005, Westech conducted an independent and unannounced third party audit on all the health care facilities in B.C. Some of the key details of this external audit are as follows:

- Audited 10% of all the rooms of every health care facility in B.C. using the new Provincial Audit Housekeeping System described above.
- Of the 10% of rooms audited, we examined a proportionally higher percentage of high risk rooms compared to low risk rooms.
- The overall score for a room is based on a weighted score for up to 19 inspection elements that could be assessed.
- The overall percentage score for a health care facility is based on the average score of all the rooms audited in that facility.
- The overall percentage score for a Health Authority is based on the average of all the scores
 of all the facilities audited within the Health Authority.

• The percentage scores for the Health Authorities are to be interpreted with a percentage system that is based on best practice in the industry. This best practice benchmark is 85%. The following provides a definition on how to interpret the percentage scores:

Percentage Range	Action
85% and above	Benchmark target - continue to monitor
75% - 84.99%	Improvement is needed
65% - 74.99%	Improvement is necessary
Below 65%	Take immediate action and re-audit

- It should be emphasized that the following overall scores for each Health Authority are based on an audit performed by Westech at a point in time and can easily vary over time. Moreover, the best measure of a health care facility's cleanliness is to monitor both the third party audit results and regular internal audit results over a period of at least one year to determine if any trends or patterns exist.
- It should also be stressed that if a facility's overall score falls into the range where improvement is necessary, the Health Authority should rectify the issue immediately and order a non-scheduled internal or third party audit to ensure that the problem has been rectified.
