The Provincial Health Services Authority had approximately 10,000 employees for the fiscal year ended March 31, 2007. Of those, 1,280 earned in excess of \$75,000. Out of these individuals:

- 355 (28%) are nurses (mainly members of the British Columbia Nurses' Union and the Union of Psychiatric Nurses)
- 334 (26%) are administrative and management staff excluded from union membership
- 347 (27%) are physicians, scientists and researchers
- 202 (16%) are paramedicals (mainly members of the Health Sciences Association of British Columbia)
- 42 (3%) are members of other bargaining units.
