- 2 Whereas the Board of Directors was active throughout Fiscal 2016/17, the sub-committees, which consist of members of the Board, were formed on the following dates: Finance and Audit Committee March 27, 2017
  - Governance and HR Committee February 21, 2017
- 3 Current meeting rates: \$500 for full-day meetings, those that are 4 hours and over; and \$250 for half-day meetings, those that are less than 4 hours. A maximum of \$500 may be earned in a 24-hour period.
- 4 Directors are reimbursed for out-of-pocket expenses while conducting Board business. This includes travel, meals and accommodation.

  These reimbursements are not considered remuneration and, as such, are not included in the above.
- 5 Meeting fees exclude three half-day Fiscal 2016/17 meetings, paid in Fiscal 2017/18, which are included in the number of meeting days attended.
- 6 No retainers or meetings fees are provided for Ministry of Health representatives.
- 7 Retainer excludes \$2,292 earned in Fiscal 2016/17, but not paid until Fiscal 2017/18.
  - Meeting fees exclude four half-day Fiscal 2016/17 meetings, paid in Fiscal 2017/18, which are included in the number of meeting days attended.
