Context

PHIX Release 4.4 will be deployed to Production on March 18, 2021 and includes updates to the PHIX User Interface to support PHIX reconcilers in the Dashboard and Submission History Report. PHIX 4.4 also contains fixes to defects found in the previous PHIX releases. This document will also describe any known issues with PHIX Release 4.4 and the remediation plan for the issues.

4. Supplemental Data is Not Processed when the Timestamp is Missing (IM-1470)
5. Warning Message Does Not Appear for Manual Review Submissions with Inactive Deceased Update (IM-1483)
6. Immunization Submission Status 2-4-5-6-11-15-15a Displays Reason as TBD (IM-1486)
7. Inbound Address on Reserve is not applied to PIR if the inbound address has same Postal Code as the PIR Address, and is automatically reconciled by PHIX ARJ (IM-1503)
8. Inbound Address and Address On Reserve is Duplicated to PIR when submitted via PHIX Manual Review (IM-549)
9. In PHIX Manual Review there is a Checkbox for User to Select 'blank' when No Address On Reserve is Submitted and Client has an existing active Address On Reserve (IM-1504)

NEW FUNCTIONALITY IN PHIX 4.4:

PHIX User Interface (UI) has been enhanced to increase efficiency for PHIX users when remediating CIS, eForm and PharmaNet records in the PHIX UI.

PHIX Dashboard

PHIX Dashboard has been enhanced so that it is easier for PHIX users to search, filter and reconcile Client & Immunization data. Here are the summary of changes made to the PHIX Dashboard for PHIX 4.4:

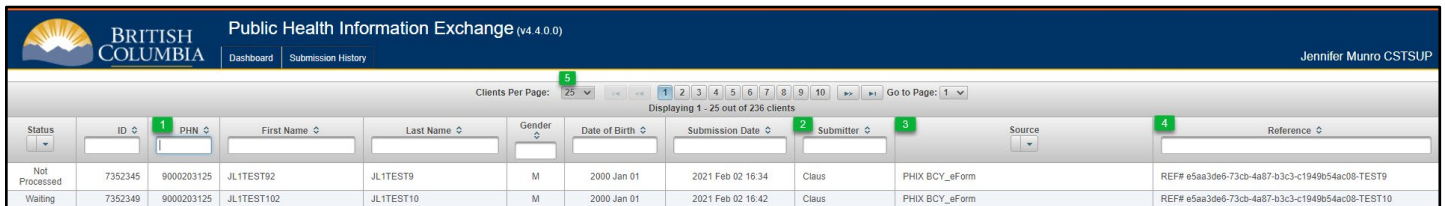


Image 1.0 - Screenshot of PHIX 4.4 Dashboard

1	New PHN Column	No column existed. PHN information was viewable only on PHIX Client Review screen.	New 'PHN' column allows users to search for a record by PHN if the inbound submission contains a PHN.
2	New Submitter Column	No column existed. Submitter information was viewable only on PHIX Client Review screen.	New 'Submitter' column allows users to search for a record by the Submitter's last name. This is useful to quickly identify when a record is submitted by EMPI or when records relating to an individual eForm submitter needs to be identified.

Submission History Parameters Page

PHIX DEFECTS FIXED IN RELEASE 4.4:

- 1. Expired Phone Numbers Effective To Dates Overwritten by Newest Phone Number (IM-812)**

In previous releases of PHIX, an incoming PHIX phone number would overwrite the effective to dates of all older PHIX phone numbers to the same date. This has been remediated and previously expired PHIX phone numbers will retain the correct effective to date when a new phone number is inserted.
- 2. PHIX Submissions Not Sent to Manual Review with Deceased Date Predating an Existing Alternate ID Effective To Date (IM-1434)**

If an incoming submission contained an inactive status for deceased with a deceased date older than an existing alternate ID's effective to date, PHIX would not send the submission to manual review. In PHIX 4.4, these submissions will be correctly identified and sent to manual review for reconcilers to remediate.
- 3. BC MSP ID Added Twice when Sent Through Manual Review (IM-1435)**

Previously when a manual review submission containing a BC MSP ID was submitted, depending on the incoming and existing effective from and effective to dates of MSP IDs, PHIX would add the same alternate ID even though the dates overlapped. In this PHIX release, BC MSP IDs will correctly update the effective from and to dates and will not cause duplicate entries to be added to clients.
- 4. Gender Identity Other Identity Text Removed when New Submission is Processed by PHIX (IM-1452)**

If a client had Other as their Gender Identity and the Other Identity text field filled in Panorama, an incoming submission without gender identity would erase the information in the Other Identity field. In PHIX 4.4, incoming submissions which do not contain gender identify will not remove existing gender identity information.
- 5. Waiting Feature Bug for BCY_eForm Records (IM-1464)**

In PHIX 4.3.1, if a user selects the 'Waiting' status on a BCY_eForm record and returns to PHIX Dashboard, they would experience issues when filtering for records and experience error messages unrelated to their workflow. This issue has been fixed and users should now be able to use the Waiting feature without any impacts to PHIX functionality and performance.

Known Issues and Remediation

The following are issues that exist in Build Release 4.4 and the workarounds to remediate the issue until it is fixed in subsequent releases.

- 1. PHIX: Address with city = "Pt. Roberts" not added correctly in Panorama UI (IM-1426)**

When PHIX receives an US address with a city (e.g Pt.Roberts), which is not in Panorama ITERM, PHIX inserts only postal code and country (United States) and as an international address. This issue is specific to city name that has a period as cities are not abbreviated in ITERM (e.g. Point Roberts). In the future release, PHIX will normalize the city names before comparing it with the city ITERM in Panorama.
- 2. Country is Not Added if Incoming Country Code is Two Characters (IM-1459)**

When an address is added by PHIX and has a two character country code (Ex. DE for Germany), the incoming address will be added to the client in Panorama without a country. To workaround this issue, countries in addresses should be sent with the full country name instead of using the two character abbreviation of the country.
- 3. Phone Number Country Code Appearing as Part of the Phone Number on PHIX Manual Review Screen and Submission History Report (IM-1460)**

When the country code (Ex. +1 for Canadian/American Phone Numbers) is present on a phone number in a PHIX submission, it will appear as part of the phone number causing the last few digits of the phone number to appear as an extension. This is a visual issue and does not affect PHIX phone number functionality, therefore a workaround is not necessary.
- 4. Supplemental Data is Not Processed when the Timestamp is Missing (IM-1470)**

If supplemental data such as a special consideration or risk factor is submitted to PHIX without a timestamp, the incoming supplemental data will not be processed or added to Panorama. Source systems are currently not submitting supplemental data therefore a workaround is not needed, however this issue will be fixed in the next release of PHIX.

5. Warning Message Does Not Appear for Manual Review Submissions with Inactive Deceased Update (IM-1483)

In scenarios where incoming submission contains an inactive deceased update with a date of death preceding the effective to date of an alternate ID, a warning message should appear preventing the user from submitting the inactive update. However, in PHIX 4.4 the user is able to submit the update and no warning message will appear. This issue will be fixed in a later release of PHIX.

6. Immunization Submission Status 2-4-5-6-11-15-15a Displays Reason as TBD (IM-1486)

When an immunization is processed by PHIX and is processed through workflow 2-4-5-6-11-15-15a, the immunization record status reason will display “TBD” instead of “Panorama Administered, Incoming Administered”. This issue does not affect PHIX immunization processing functionality and is a visual bug. This issue will be addressed in a future release of PHIX.

7. Inbound Address on Reserve is not applied to PIR if the inbound address has same Postal Code as the PIR Address, and is automatically reconciled by PHIX ARJ (IM-1503)

PHIX’s address logic compares only the inbound address postal code to the active existing address postal code in order to determine if the address is a match. Due to this logic, in the case where the inbound address matches on postal code and contains an Address On Reserve, and the existing record has either no Address on reserve/ a different address on reserve, the inbound value for Address on Reserve will be dropped as PHIX believes the address is the same (due to match on postal code) and does not insert a new address. See below for example:

As an interim solution, a script will be deployed to identify records where the inbound Address on Reserve value has been dropped due to match on postal code and the script will automatically insert the Address On Reserve value into the Client record.

8. Inbound Address & Address On Reserve is Duplicated to PIR when submitted via PHIX Manual Review (IM-549)

If an inbound record requires PHIX manual review due to a client discrepancy and contains a different inbound address/address on reserve, and the user selects both check boxes in PHIX Manual Review, the address and address on reserve will be inserted into the Client record twice.

Users have been directed to select only the **Address On Reserve** checkbox so that the inbound address and Address on Reserve is added to Panorama correctly. For more details please visit the *Covid-19 Imms Digital Solution eForm Guide to PHIX Manual Reconciliation*.

9. In PHIX Manual Review there is a Checkbox for User to Select 'blank' when No Address On Reserve is Submitted and Client has an existing active Address On Reserve (IM-1504)

If an inbound record requires manual review in PHIX, and there is no incoming address on reserve value, but the client record in Panorama has address on reserve, a check box REPLACE Panorama value will appear. If a user selects the blank REPLACE Panorama value, a duplicate address entry will be added to PIR. As an interim solution, users have been instructed to not select the REPLACE Panorama value when there is no submitted address on reserve value. Please refer to the *Covid-19 Imms Digital Solution eForm Guide to PHIX Manual Reconciliation* for more details.

10. Address with Address On Reserve created via PHIX Manual Review results with Client having two Preferred addresses in Panorama (IM-1507)

This scenario occurs when a client exists in Panorama with a Panorama created address, and an inbound PHIX record for the client contains an address on reserve and requires manual review. If the inbound address on reserve is submitted to Panorama through manual review, the address will be inserted with the preferred indicator, and the existing Panorama address will also have a preferred indicator.

As an interim solution, the PHIX team will query Production daily to identify and manually remediate any impacted records. A fix for this defect will be available in the PHIX 4.4.1 patch.

11. PHIX drops Client Address: City, and Province/State if only City, Province/State and Postal Code are Submitted (IM-1510)

This issue occurred as a result of the PHIX 4.4 deployment and affects mainly Pharmanet records. If an incoming address update contains only the City, Province/State and Postal Code, PHIX will only add the Postal Code and Country to the Panorama Client Demographics page. To remediate this issue, a fix will be deployed in a patch, PHIX 4.4.1, which will add all the incoming address information and a script will be created to update existing addresses created by PHIX that were affected by this issue.
