## Introduction

This report is a companion document to the *PHSA Research and Student Education Metrics Consolidated Report* and provides further detailed metrics according to PHSA's Student Education Metrics Framework. It reports on metrics across PHSA on Student Education Capacity, Building Effective Partnerships and Collaborations that Support Innovation, and Monitoring the Quality of Clinical Learning Environment and Results. As well, the report includes student education summaries for the following programs: BC Cancer, BC Children's Hospital and Sunny Hill Health Centre, BC Women's Hospital & Health Centre, BC Emergency Health Services, BC Mental Health and Substance Use Services, and BC Centre for Disease Control.

The intent of the report is to:

- Acknowledge, celebrate, and monitor the commitment of PHSA's teams who support student education.
- Recognize collaborations with the academic partners across the province.
- Provide data to inform operational and strategic decisions, including workforce planning, building capacity for student education, quality practice environments, and priority areas of focus and innovation.
- Identify opportunities for further development.

Of note, the COVID-19 pandemic affected student practice education — the data presented in this report reflects these impacts. The extent of changes to student placement requests was substantial during the pandemic, and every effort was made to track and document the changes accordingly so that the data reflects the actual experiences of students' clinical learning throughout the year. The data for this fiscal year begins on April 1, 2020, which was two weeks into the suspension of most student placements that were previously underway. Significant collaboration occurred across all partners to develop and implement plans to resume placements for students in health programs. As the report includes data for three fiscal years, the decrease in student numbers or placement hours is attributed to the various factors of the pandemic response.

The experience of the pandemic has strengthened connections amongst all stakeholders who support student practice education as we worked together to maintain the learning continuity for students in health programs. Remarkably, even with the necessary adjustments this year, 2,782 students had learning experiences across PHSA sites.

### PHSA AGGREGATE ANALYSIS

This summary data supports our ability to plan and communicate our placement capacity and monitor our commitments to student education.

#### **BUILD STUDENT EDUCATION CAPACITY**

#### **Placement Activity**

In FY 20-21, PHSA programs provided 234,496 student hours (excluding medical students), a decrease of 28,604 (11%) hours. BCEHS, BC Women's, and BC Cancer all experienced a decline from previous FY in the number of hours due to COVID-19 placement suspensions. The disciplines most effected were nursing, radiology technologist, and paramedics.

BC Children's Hospital, Sunny Hill Health Centre, Mental Health and Addictions and BCCDC, all saw increases in their number of student hours. A breakdown of student hours and students by discipline, sub-discipline and fiscal year can be found in Table 1. This table can be used as a reference for comparing PHSA commitments to student education with our short and long-term workforce planning and other team planning processes.

The number of Medical Undergraduates (MDUG) and Post Graduate Medical Education (PGME) students (1,317), placements (5,217) and days (125,968) for all clinical placements by program can be found in Tables 2 and 3. Total number of days are not representative of actual days worked, rather they are an indicator of time spent in a clinical area.

The Medical Doctor Undergraduate program (MDUG) had a total of 451 distinct students, representing 1,562

placements and 23,537 days, arriving at PHSA facilities from April 1, 2020 – March 31, 2021. While the number of students remained stable, there was a 30% reduction in the number of placements and a 26% reduction in the number of days due to COVID-19 suspensions in the MDUG program but an increase in all metrics for the PGME program. See Table 2 for a breakdown by specialty.

The Post Graduate Medical Education program (PGME) had a total of 866 distinct students, representing 3,655 placements and 102,431 days, arriving at PHSA facilities from April 1, 2020 - March 31, 2021. The number of students, placements and hours were slightly higher than

the previous FY and thus were not impacted by the COVID-19 pandemic. See Table 3 for a breakdown by specialty.

The number of distinct students (1,221, down 10% from the previous FY) by discipline and sub-discipline by month for PHSA Overall is seen in Table 4, allowing the organization to see at a glance the types of students and volumes that have been supported throughout the last fiscal year.

This data can be used to:

- Anticipate student volumes by discipline at each site throughout the calendar year.
- Plan for students in advance, including support for the planning required for preceptor assignment, development, and availability.

 Schedule students learning activities such as CST training, and interprofessional collaborative practice events and learning opportunities.

Note: since the length of student placements vary, the students listed in one month may still be on-site in subsequent months; excluded from these graphs are medical students and on-car paramedic placements whose current policies result in an equal distribution of placements throughout the year.

#### Preceptor/Educator Training

Preceptors are PHSA staff who support the learning experiences of students enrolled in a designated program of study with a post-secondary institute, for a defined period of time. Depending on the program or role, preceptors may be known by other terms such as field guides, supervisors, or practice educators.

By sharing their expertise and welcoming prospective members into the role, preceptors make an important contribution to the learning experiences of individual students and to the future members of the healthcare team. The role of preceptor is recognized by the professions, academic institutions, health care organizations and leaders as vital to supporting the delivery of excellent health care.

PHSA staff participation in preceptor development is a key measure of Student Education readiness and an indication of available capacity to support students. Currently, PHSA utilizes the provincially developed Educator Pathway (EP) program to support staff who host students during the clinical placement component of their health care education

programs. Level 1 of the Educator Pathway is a one-session format that provides key concepts, tools, and resources for preceptors. This year, 287 preceptors participated in sessions offered by BC Children's Hospital, BC Women's Hospital & Health Centre, BC Cancer, BCEHS, BC Mental Health and Substance Use Services and PHSA Corporate. See Table 6 below for a breakdown of preceptor training by agency and level for fiscal year 2020-21.

BCEHS also offers a specific version of the training for Primary Care Paramedic and Advanced Care Paramedic preceptors. Within FY 2020-21, BCEHS offered preceptor orientation sessions for 88 paramedics.

The number of preceptors participating in training has increased from 250 to 287 for the Level 1 of the Educator Pathway. This increase can be accounted for through an overall increase in number of training sessions offered, support from area leaders for preceptors to attend training, and more accurate tracking and reporting of participant attendance.

In addition to the Level 1 Educator Pathway sessions offered this year, the Level 2 & 3 sessions of the Educator Pathway Program were offered for a second year. Levels 2 and 3 expand upon key principles taught in Level 1 and provide inter-professional attendees with an array of tools for establishing positive learning environments in clinical settings.

Understanding the current list of preceptors and their participation in training sessions allows PHSA to review its organizational approaches for identifying, supporting and recognizing people in this important role. Future considerations may include advancing the learning sessions and resources that are available to preceptors, launching specific celebration and recognition events, and aligning available preceptors with student education activity planning processes.

#### **Preceptor Activity**

PHSA had a total of 673, up 67 from 2019-20, active preceptors in FY 20-21, across all PHSA disciplines. While the total number of preceptors increased, the number with an active placement decreased by 21. Excluded from these data are the BCEHS preceptors, as they do not currently utilize HSPnet for paramedic program placements. In addition, although the PGME and the MDUG programs utilize HSPnet for placement access into particular clinical departments, they do not utilize HSPnet to assign physician preceptors as this is managed by UBC outside of HSPnet.





FIGURE 2 Number of Preceptors by Student Placement Activity and Fiscal Year – All Other Disciplines

The number of preceptors with and without an active placement by fiscal year for nursing is shown in Figure 1 and for non-nursing in Figure 2. The number of active preceptors with and without a placement, allows for a closer look at the alignment with team interest and capacity for supporting students.

FIGURE 1 Number of Preceptors by Student Placement Activity and Fiscal Year - Nursing




All other non-nursing disciplines include: BCCA Nutrition, BCCDC, C&W Audiology, Child Life, Diagnostic Imaging, Labs, Library Services, Nutrition Services, Ophthalmology, Pharmacy, Quality, Risk & Safety, Respiratory Therapy, Forensics Rehab. All had less than 5 preceptors with placements.

The number of trained and active preceptors in BC Emergency Health Services (BCEHS) is detailed below in Figure 3. This includes all preceptor and student training for the Primary Care Paramedic and Advanced Care Paramedic

courses. While a preceptor may be trained, they may not be actively taking students. Training for preceptors for BCEHS other programs (Critical Care Paramedic, Infant Transfer Team, and Dispatch) are excluded.

One element of the total cost of Student Education is staff time related to direct supervision of students. These activities include orientation of the students/faculty to the site, unit and/or program, planning of daily learning activities that meet learning objectives, skill demonstrations, supervision of students while they practice, supporting student performance; and, contributing to student assessments, and evaluations. Approximate costs are calculated using the ration of staff hour to student hours, 1:20 for group placements, 1:1 for Paramedic placements and 1:5 for all other disciplines for preceptor placements. Hourly wages are either \$40 or \$50 per hour average staff salary cost. Not included in the estimate are costs associated with preceptor training, student education administration, clinical educator time in support of student education

activities, equipment and supplies, orientation, ID cards, impact on diagnostics, drugs and therapies, computer access, simulation learning events, or other relevant costs. There are additional in-kind costs that teams contribute to student education but quantifying the approximate dollar-value of staff time is one way of acknowledging PHSA's commitment to students and academic partners across the province.

Table 7 shows the estimated cost of staff time by discipline for FY 20-21. The large decrease in total costs can be attributed to the decline in paramedic placements due to COVID-19. Excluded from this table is estimated cost related to medical students.



#### BUILD EFFECTIVE PARTNERSHIPS AND COLLABORATIONS THAT SUPPORT INNOVATION

Student education requires the ongoing cultivation of relationships amongst a range of stakeholders including government, academic institutions, health organizations, regulatory bodies, professional associations, unions, care teams, patients, and the public. In addition to Educational Affiliation Agreements, PHSA participates in a range of formal Advisory Committees, Working Groups and Forums as well as informal and ad hoc meetings and presentations with its partners.

PHSA has affiliation agreements with sixty-four (64 educational institutions, in both the public (78%) and private (22%) sector. See Figure 4 for a breakdown by region and sector. The reduction in the number of public BC affiliation agreements is due to combining all agreements for UBC and SFU into single agreements. In addition to these, BCEHS has affiliation agreements with JIBC, Columbia Paramedic Academy, and AET Paramedic Academy. PHSA also has affiliation agreements (Inter-health authority agreements) in place with other BC Health Authorities and BC Emergency Health Services to support continuing professional development. Of note is that although private institutions represent about 20% of affiliation agreements, they represent less than 5% of total student practicum hours. For a detailed list of education partners see Appendix C.

While PHSA has 64 partnerships in place, 91% of student practice hours for FY 2020-21 were with ten (10) public institutions (see Figure 5). A detailed listing of student hours by institution, discipline and subdiscipline can be found in Appendix D. It is important that PHSA continues to strengthen its relationship with primary academic partners and evaluate relationships with other affiliates to determine whether continued affiliation is warranted. Note that student hours for UBC does not include medical student/resident placements.



PHSA programs provide outpatient or ambulatory services delivered by inter-professional teams. PHSA monitors student activities across placement settings to ensure students have learning opportunities in a variety of patient care settings. New categories of placement setting were

applied this year and reflect similar percentages for service delivery settings at PHSA facilities. See Figure 6 for the distribution of student hours by placement setting.


FIRGURE 6 Distribution of Student Hours by Placement Setting by FY

#### MONITOR THE QUALITY OF CLINICAL LEARNING ENVIRONMENT AND RESULTS

Teams. programs, health organizations, academic institutions, government partners and other stakeholders are all interested to know more about students' experiences while on their placements, in order to monitor the quality, make continuous improvements, and resolve any emerging issues. These diverse stakeholder groups are keen to collaborate on an approach to gather this information without inundating students with multiple requests, and that will effectively manage the privacy and confidentiality of students' responses.

The processes and approaches for gathering student feedback are varied across discipline, academic program and PHSA program and include online surveys, formal feedback, meetings and committees, as well as informal suggestions and comments. Currently, PHSA gathers information from a survey embedded in the New Hire Orientation course.

Results from the New Hire Orientation Online Course on Learning Hub, which includes a survey of previous practice placement activities (see Appendix E) are reported for a fourth fiscal year. Combined results are show in Table 9 and 10.

Out of the 1,760 respondents from April 1, 2020 – March 31, 2021, 11% or 195 had a placement at a PHSA site. While this is a 9% reduction from FY 2019-20, there was a 35% reduction in the total number of survey respondents compared to F 2019-20. This course is not mandatory so may represent a lower response rate and not necessarily less hires. See Table 9 for a breakdown of new hires by placement program that represent 85% of the total hires. The top three programs for new hires with a PSHA placement disciplines are Primary Care Paramedic, Nursing-RN, Medical Lab Assistant.

The top three educational institutions for new hires with a PHSA placement are JIBC, BCIT, and UBC. See Table 10 for a breakdown of new hires with a practice placement by educational intuition for all institutions with over 5 placements.

#### **BUILD STUDENT EDUCATION CAPACITY**

#### **Placement Activity**

In FY 20-21, BC Cancer provided 24,965 student hours, a 12% decline from FY 19-20 (excluding medical students) of which all were one-to-one preceptorships (supervised by a PHSA preceptor/employee). The top 3 disciplines in FY 20-21 by total student hours are Therapist (63%), Technologists (12%) and Nursing (10%). A breakdown of student hours and students by site, discipline, sub-discipline and fiscal year can be found in Table 11.

#### **Placement Activity**

In FY 20-21, BC Children's and Sunny Hill Health Centre provided 106,181 student hours, a 4% increase over FY 2019-20 (excluding medical students) of which 52% were one-to-one preceptorships (supervised by a PHSA preceptor/employee) and 48% were group placements

(supervised by an instructor provided by the educational institution). Nursing placements represent 47% of total student hours in FY 20-21. A breakdown of student hours and students by site, discipline, sub-discipline and fiscal year can be found in Table 17.
