B.C. government statements

- Since our last bulletin, the following updates were issued by Minister of Health, Adrian Dix, and B.C.'s Provincial Health Officer, Dr. Bonnie Henry:
 - Statement on Monday, April 13: Emphasizes ongoing support for the outbreak at Mission Institution (a federal correctional centre), fully activated/enhanced border control measures, and gratitude for all those who are doing their part to practice physical distancing.
 - Statement on Tuesday, April 14: Highlights the Mobile Medical Unit's deployment from the Vancouver Convention Centre to Abbotsford Regional Hospital to

provide additional patient capacity and assistance to the Correctional Service of Canada.

- Minister of Mental Health and Addictions, Judy Darcy, also released a statement today in recognition of the overdose crisis as a public health emergency in B.C. In the statement, she emphasizes that, while the COVID-19 pandemic is adding unprecedented challenges, the urgency to protect people who use drugs is greater than ever before.

ZOOM for Healthcare: Safe and secure

- *ZOOM for Healthcare* is a licensed tool offered for virtual health visits by all health authorities across in BC and is compliant with Canadian data protection regulations (BC FIPPA, PIPEDA and PHIPA).
- *ZOOM for Healthcare* now includes additional features for enhanced privacy and security of virtual encounters with patients, including:
 - All virtual health visits are now automatically password protected;
 - Local and cloud recording have been disabled;
 - File sharing is no longer possible; and
 - Virtual 'Waiting Rooms' have been enabled.
- All workstations have the current up-to-date ZOOM desktop client version with applicable security enhancements.

Best practices to ensure privacy using ZOOM for Healthcare

- Mitigate the risk of "ZOOM-bombing": encourage the meeting host to "lock" the meeting once all participants have joined the virtual health visit.

- Prevent unwanted visitors: providers are encouraged to use auto-generated meeting ID to avoid any outside parties entering the virtual 'Waiting Room'.
- Communicate to patients: ensure patients are aware that they can still join their Virtual Health Visit without compromising privacy and security. **Advise patients not to share their Virtual Health Visit invitation with others.**
