Federal government announces production of more medical supplies and equipment

- The [Government of Canada announced today](#) that it is building a secure, domestic supply of needed items to protect frontline health workers. Nearly 5,000 Canadian companies have offered their expertise and capacity as we work together on projects that include:
 - Purchasing made-in-Canada ventilators through an accelerated process
 - Developing easy-to-produce ventilators using off-the-shelf, easily accessible parts
 - Using innovative, alternative materials to augment the supply of medical gowns
 - Establishing and securing new supply chains to produce medical gowns from new Canadian sources
 - Purchasing and producing masks, including supporting increased capacity to produce both surgical and N95 masks in Canada
 - Purchasing hand sanitizer from Canadian companies and identifying/guiding new producers through a licensing and procurement process

B.C. announces new spaces for vulnerable people to self-isolate

- To support British Columbians who need a place to self-isolate and to reduce the spread of COVID-19, [the Province announced today](#) that it is partnering with local governments, non-profits and the hotel industry.
- So far, more than 900 spaces have been secured at 23 sites including hotels, motels and community centres throughout B.C.
- These new spaces are a critical part of how we can support those who are vulnerable in our community, including those who are experiencing homelessness or living in communal locations where COVID-19 could spread more quickly.

Temporary staff/medical staff hotel accommodations

- In order to best protect the health & safety of our staff and their families, PHSa has created a temporary accommodation program.
- The program provides:
 - **Employer-paid accommodation** to those who meet eligibility criteria
 - **Accommodation at a discounted rate** for staff who do not meet eligibility criteria
- The eligibility criteria for employer-paid accommodations:
 - If you have been redeployed by PHSa to a geographic location other than your primary location and cannot safely commute to and from your primary residence;
 - If there is an active outbreak in your place of work and the nature of your work within that location may put you directly at risk of contamination, or you are regularly working in active COVID patient care (i.e. on a COVID-ward) and cannot sequester yourself from other individuals you are living with in your home.
- Staff who do not meet the eligibility criteria may access accommodation at a discounted rate (self-pay options), [which are listed on our website](#).
- The following principles allow for temporary staff accommodation:
 - “Staff” includes PHSa employees, medical staff, residents, and any contractors (i.e. housekeeping) who are key to our COVID-19 response;
 - Where possible, accommodation is provided as close to the worksite as possible;
 - The program will only partner with commercial providers who meet our criteria for health, safety and cleaning guidelines;

- Food is not provided as part of the program;
- Pets and/or family members cannot be accommodated.
