

COVID-19 ORIENTATION GUIDELINES AND EXPECTATIONS FOR FACULTY, INSTRUCTORS AND STUDENTS AT BCMHSUS

This summary is to provide guidance and resources for all schools with practice education activities placed at our BCMHSUS sites during the COVID-19 Pandemic. We will be limiting the number students working with presumptive and COVID positive patients and families. For questions or concerns, please connect with your preceptor, unit leaders, school contacts and/or academic practice leads (see resources below).

It is **essential** that Faculty and Instructors supporting students are familiar with the current policies, practices and site specific information. We also recommend the review of the most recent [BCMHSUS and PHSA COVID-19 updates](#).

Preparing for your Practicum

1. **Review [BCMHSUS SHOP](#)** regularly for new and updated policies (see policy links below).
2. **Violence Prevention:** Our PVPC Core Classroom course is once more available. For FPH and clinics ensure you have completed the PVPC core classroom training prior to commencing placement. For BCMHA, your Core Classroom will be scheduled once you have commenced your placement.
3. **Please complete the [COVID-19 Self-Screening Assessment Tool](#)** daily, prior to start of a shift.
 - **If you answer YES to any screening question, please stay home. The practicum is temporarily suspended.**
 - **You will need to confirm that you have completed the self-assessment when you arrive on shift**
 - Absences should be reported to Post-Secondary Institution (PSI) Faculty and Instructor as well as your Preceptor and the unit of your placement.
4. **PPE:** Where required, PPE will be provided for you on site.
5. **If you become symptomatic** while on-site, please leave the practice setting immediately.
 - Notify your Preceptor, the unit of your placement, and the PSI Faculty and Instructor.
