Updates and Reminders:

1. First PHSA Medical Staff Town Hall of 2026

On Tuesday, January 27, PHSA Medical & Academic Affairs hosted the first medical staff town hall of 2026. Hosted by Dr. Sean Virani, vice president, Medical & Academic Affairs, the town hall included updates from the following guest presenters:

- Dr. Penny Ballem, interim President & CEO provided an update on the Health Authority Review, the standing up of the shared services organization and what is ahead for the refreshed PHSA mandate.
- Dr. Titus Wong and Dr. John Harding with the OSWELL team provided a summary of the 2025 PHSA medical staff wellness survey results.
- Dr. Ran Goldman, HAMAC Chair and Candice Manahan with the Medical Affairs team provided a brief HAMAC update as well as an update on the newly refreshed medical staff rules.

2. Reminder: Self-Report Your Influenza Protection Choice

During viral respiratory illness season, all PHSA staff, including medical staff, must report their influenza protection choice as required by PHSA's [Influenza Prevention policy](#). So far, only 23 per cent of medical staff have self-reported.

When vaccination information is up to date, Workplace Health can respond faster during influenza outbreaks and take the right steps to protect vulnerable patients and staff.

Please [self-report](#) soon after receiving your influenza vaccination using a networked computer. Your quick action helps keep our teams and patients safe.

3. New Video Series to Support Indigenous-Led Resolution in Clinical Practice

A new [five-part video series](#) now complements the [Indigenous-Led Resolution Guide](#), supporting our shared journey to improve cultural safety in health care and to uphold the right of First Nations, Inuit and Métis Peoples to self-determined resolution when harm occurs.

This series features insights from leaders — including Dr. Garth Meckler, a pediatrician at BC Children's Hospital — who have participated in Indigenous-led resolution processes. As part of the [Indigenous-Specific Racism and Discrimination \(ISRD\) Response and Review approach](#), it upholds the right of Indigenous patients and families to define what meaningful resolution looks like for them, supports recommendation five of [In Plain Sight](#) to strengthen complaint processes addressing individual and systemic ISRD, and aligns with the [BC Cultural Safety & Humility Standard](#).

PHSA Medical and Academic Affairs, in partnership with Doctors of BC, is launching a new series focused on medical staff wellbeing, safety, and practice. The sessions will feature speakers from across B.C. and offer CME-accredited, practice-focused learning.

The first session, presented by PHSA's Psychological Health & Safety team, focusses on neurodiversity in the workplace and explores neurodiversity, psychological safety, and strengths-based strategies to build more inclusive, high-performing teams and improve patient care.

5. Physician Quality Improvement (PQI) Level 2: Introduction to Quality Improvement Workshop

PQI offers Level 2: Introduction to Quality Improvement, a virtual workshop that is delivered over two half-day sessions. Participants will learn the key quality improvement tools and techniques used in health care settings and how to apply them in practice.

The workshop is open to all PHSA physicians, leaders, and medical staff, and is recommended for any staff working on QI projects. **Physicians are eligible for CME credits** and may be compensated for seven hours at the JCC sessional rate for completing the full workshop. A certificate of completion will be awarded to those who attend the entire workshop (day 1 and 2).

6. Physician Quality Improvement (PQI) Level 3: Applied Training Program – Fall 2026 intake

The PHSA Physician Quality Improvement (PQI) program is now accepting applications for its 10TH Cohort beginning in fall 2026. In partnership with the Specialist Services Committee, PQI provides in-depth quality improvement (QI) training designed to build physician and medical staff leadership in QI across PHSA. Over one year, participants attend seven full-day (or equivalent) learning sessions and complete a QI project supported by the PQI team. The sessions are a mix of in-person or virtual sessions (not hybrid).

Eligibility and Requirements

Eligible participants include medical staff (physicians, NPs, midwives, dentists and clinical scientists) who practice within PHSA programs and services (BCCH, BCWH, BCC, BCCDC, BCEHS and BCMHSUS). PQI also accepts operational, nursing and allied health dyad partners participating alongside the primary medical staff applicant.

What to expect

- PQI participants learn about QI methodology and tools applied directly to their own QI projects with the support of dedicated PQI technical staff.
- Funding is available for physician participation in the training program and project work.
- Physicians are eligible for **CME credits**
